Out of all the Writ Petitions against the Authority's Orders, Sh. Farman Ali and Sh. Shahanullah have already represented the Authority in 41 matters. Considering the experience and adeptness of these two advocates in the anti-profiteering jurisprudence, the Authority decided to waive off the minimum eligibility criteria mentioned in Para 4(b) of the Guidelines for the Empanelment dated 20.07.2020, for both of them.

The empanelled Advocates/ Law Firms shall be communicated as per the said Guidelines.
