Sub:- Engagement of Legal Consultant (Retired Govt. Servant) in the National Anti-Profiteering Authority (NAA) - reg.

Please refer to your application dated 15/12/2020 in respect of the Vacancy Circular dated 25.11.2020 for engagement of Legal Consultant (Retired Govt. Servant) in the National Anti-Profiteering Authority for the period of 01 (one) year from the date of engagement.


2. In this regard, the National Anti-Profiteering Authority is pleased to inform that you have been selected to be engaged for the post of **Legal Consultant in the National Anti-Profiteering Authority (GST)** for the period of 01 (one) year from the date of engagement or till the tenure of the Authority whichever is earlier, on the monthly remuneration of Rs.1,25,000/- (One lakh Twenty five Thousands only) per month (fixed) with the Terms & Conditions as under:

- (i) This appointment will be purely on contract basis, which is initially for a period of one year, which may be extended by the Authority, subject to the satisfactory performance and requirement of your services. Performance will be reviewed every year and the time of engagement contract shall be extended or discontinued as the case may be, depending on the performance. The decision of National Anti-profiteering Authority shall be final in this regard.
- (ii) The remuneration would be the 125000 (fixed). The total monthly remuneration and the pension drawn by the consultant shall not be more than the Last Pay Drawn by him calculated at the current rate of Dearness Allowance. Rate of Dearness Allowance shall be fixed at rate of dearness allowance on the date of issue of the mentioned Vacancy Circular.
- (iii) You will not be entitled to any separate monthly allowance including conveyance allowance, HRA etc. However, in case, you are required to travel outside Delhi in connection with the official work/assignment, the National Anti-Profiteering Authority shall reimburse the actual cost of travel and daily allowance as per the Rules/regulation of the Central Government applicable to Group-A Gazetted Officer.

- (iv) You will not be eligible for any other facilities such as residential telephone, residential accommodation, CGHS or medical reimbursement, personal support staff, Transport facilities etc.
- (v) You will be eligible for 08 days leave in a calendar year (on Pro-rata basis). Therefore you will not draw any remuneration for the absence in case of absence beyond 08 days in a year. Also, Un-availed leave in a year can't be carry forward to next calendar year.
- (vi) The working hours will be same as for regular Govt. employee working in this Authority. No Extra remuneration shall be paid for working beyond office hours or on Saturdays/Sundays/Gazetted holidays. Compulsory leave in such cases shall be at the discretion of the competent authority.
- (vii) You will be required to discharge the duties as assigned to you by the National Anti-Profitteering Authority.
- (viii) The Income Tax or any other tax liable to be deducted, as per the prevailing rules will be deducted at source before effecting the payment for which the Authority will issue TDS Certificate.
- (ix) You will, in no case, work or represent in court or before any other authority, tribunal etc. or give opinion, advice to any person other than the National Anti-Profitteering Authority in any matter during the period of your engagement with this Authority. Further, in no case, you will act, or conduct anything regard to any person or render any advice to National Anti-Profitteering Authority which is adverse to the interest of this Authority.
- (x) The contract may be terminated by the Authority, after giving one month notice, in following situations:
- If you are unable to do the assigned work.
 - If the National Anti-Profitteering Authority chooses not to renew the contract at the end of period.
 - If the tenure of the National Anti-Profitteering Authority expires any time before the expiry of the term of engagement.
- (xi) The National Anti-Profitteering Authority reserves the right to terminate the contract without giving any reasons, explanation or whatsoever with immediate effect without any remuneration or notice period on the ground of misconduct.
- (xii) Termination shall be effected by written notice of 30 days served to you. The termination will be without prejudice to either party's rights accrued before termination.
- (xiii) You are required to give 30 days' notice to the National Anti-Profitteering Authority in case you opt to quit the assignment.
- (xiv) Jurisdiction for legal disputes, if any, arising during the period of the contract, shall be with Delhi Courts only.
- (xv) You are bound not to disclose any information by him/her during the period of such engagement to any person other than the National Anti-Profitteering Authority at any time whether during continuance of such engagement or after its severance. Further, you will not represent; advice or work for any person against the interest of National Anti-Profitteering Authority/ Central Govt. for 02 years from the date of termination of this engagement, in the matters related to this Authority.

- (xvi) During the period of engagement with this Authority, you would be subject to the provisions of India Official Secret Act, 1923 and will not divulge any information gathered during the period of your assignment to anyone who is not authorized to know the same.
- (xvii) You are directed to return the duly signed duplicate copy of this letter indicating your unconditional consent.
